### District Personal Computing Device User Agreement

A personal computing device is an instructional tool for promoting educational excellence in District 709. They are District 709's property and therefore the district reserves the right to demand immediate return of the device, access content on the device and access content stored by the device on any external server. The primary goal for using personal computing devices in District 709 is to promote 21st Century Learning Outcomes. For purposes of this Agreement, all personal computing devices issued by the district are designated as "iPad". This term should be interpreted broadly to include district iPads, other tablets, laptops, or any other district issued equipment, which includes a computer processor.

#### Responsibilities

- I understand my iPad is to be used solely for educational purposes.
- I will come to school each day with my iPad fully charged.
- When in class, I will only use the iPad in a manner that is on-task with the current lesson being taught.
- I am responsible for my iPad at all times including when I am not using my device. During those times, it will be stored in a secure or locked environment.
  - My iPad will be always stored in the provided case. I understand it is still vulnerable to damage if dropped, smashed or crushed even when secured in the provided case.
- I will not apply any permanent marks, decorations or modification to the iPad.
- I will only use the iPad which has been assigned to me, unless directed otherwise by a staff member.
- I am responsible for the care and protection of the iPad and will report any damage or malfunction immediately.

I will not attempt to repair or gain access to the internal electronics.

- I will report the loss or theft of the iPad immediately.
- I will not expose the iPad to excessive heat (like a hot car).
- I will keep my password confidential.
- I will not use another individual user account.
- I agree to return the iPad, case, plug and cord in excellent condition at any time requested by a District 709

official and at the end of the school year or if I am un-enrolled from District 709.

## **Safety**

- I will only access educationally appropriate applications or websites which reflect the core values of District 709.
- Use of the iPad will only occur under direct parent, guardian or staff supervision to protect me from dangerous or inappropriate content.
- I will not use the iPad to post personal information (full name, address, email, phone number) online or engage in online communications without supervision or direction from a parent, guardian or staff member.
- I will follow the policies outlined in the appropriate District 709 Student Handbook.
- I will not use the iPad to engage in academic dishonesty.
- I will not use the iPad to access, submit, post, publish or display any defamatory, inaccurate, abusive, obscene, profane, sexually oriented, threatening, racially offensive, harassing or illegal material.

Failure to follow any of these expectations may result in privileges being denied, revoked, or suspended at any time, as well as other consequences specified by the student handbook. In the event of disciplinary action, completion of all classwork remains the responsibility of the student.
